# **Tohono O'odham Nation Health Care**

Below are updates or new changes that will occur with TONHC to help address the COVID-19 response:

- **Pharmacy Hours:** Due to COVID-19, Sells Hospital Pharmacy must reduce the hours available for Outpatient Pharmacy services. Effective Friday, March 27, 2020, the Sells Hospital Pharmacy will be available for refills and new prescription fills according to the following schedule:
  - Monday Friday: 8 am 6 pm
  - Saturday: 10 am 4 pm

 Inpatient Visitation: Due to the Coronavirus (COVID-19) and for the safety of the hospitalized patients, Sells hospital Inpatient Unit will no longer allow visitors except in special circumstances. Special circumstances are if the patient is under the age of 16 years; or the patient is receiving end of life care; or there are other special circumstances determined appropriate by physician, they will allow one adult visitor per day. In Effect:

- TONHC continues to stop ALL non-urgent visits at our facilities, until further notice.
- ALL services at Santa Rosa will be suspended until further notice in order to ensure adequate staffing at Sells Hospital.

COVID-19 or novel coronavirus disease cases are widespread in the US and planning and preparation is key. Together as a Nation, we can protect ourselves and our communities from getting and spreading COVID-19. Everyone has a role to play in getting ready and staying healthy.

# **Keeping Healthy**

- Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer that contains at least 60% alcohol.
  - It is especially important to clean hands after going to the bathroom; before eating; and after coughing, sneezing or blowing your nose.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Stay at home when you are sick.
- Avoid close contact (within 6 feet) with others.
- **Cover your cough or sneeze** with a tissue or your sleeve (not your hands) and immediately throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces.

## ARIZONA

Updated Arizona recommendations are listed below:

- State-wide closure of Arizona schools through Friday, April 10, 2020.
- The Governor also <u>activated the National Guard</u> to alleviate food supply chain delays and to mitigate other impacts of COVID-19 in Arizona, and he announced the launch of the State's <u>2-1-1 Covid-19</u> <u>Hotline</u>.

## **Tohono O'odham Unified Command**

#### Food Distribution:

Phoenix Urban Indian Association – Perishable food products were picked up Tuesday, March 24, 2020.

Tucson Urban Indian Association – Perishable food products were picked up Thursday, March 26, 2020.

Districts - The Unified Command coordinated with District leaders for consumable products distribution at the Sells Recreation Center on March 25, 2020; distribution to households will be coordinated by District leaders. All 11 Districts picked-up their District's.

The consumable supplies distributed to all 11 Districts consist of toilet paper, napkins, folding towels, cleaning/sanitation products, trash bags, Kleenex tissue, and a pallet water.

# March 20, 2020 - March 26, 2020



## **Unified Command Current Objectives:**

- Ensure policy and processes are in place to support policy decision making authority for stakeholders to include the first responder community
- Maintain continuous operational coordination with TON-HC Hospital and Clinic locations
- Maintain operational communications with internal and external stakeholder is an ongoing effort
- Integrate best practices and up-to-date safety guidance for the first responder community, healthcare/medical community, and supporting personnel
- Ensure the continuous inventory and accountability of available Personal Protective Equipment (PPE) across the Unified Command and distribute to those that are assigned or performing in disciplines that require PPE protection

## **Command Emphasis:**

- Maintain Unified Command between DPS, TON-HC, and TODHHS
- Ensure accountability of deployed personnel/equipment that receive work assignments thru the EOC
- Keep the Policy Group and senior leadership adequately informed
- Establish a battle rhythm, to include Planning P and Incident Action/Coordination/Support Plan schedule
- Facilitate timely processing and documentation of resource requests using the EOC resource ordering process via Microsoft Teams
- Acknowledge that in addition to the COVID-19 pandemic public safety will still need to coordinate response to day-to-day (LE, Fire, EMS)
- Develop COVID-19 situational awareness of impacts, response actions, and gap analysis for effective support
- Build response organization common operating picture for support and coordination being provided throughout the EOC
- Coordinate unified public messaging with all partner agencies

#### **General Situational Awareness Information:**

- The Unified Command received a limited SNS package from Pima County. Unified Command will distribute to Public Safety personnel based off resource requests to include Ajo Ambulance.
- Governor Ducey has issued activated the Arizona National Guard (AZNG). As of March 26, 2020 the AZNG has mobilized 862 personnel. Approximately an additional 111 more personnel will be in-process. Task Force Logistics successfully completed 9 missions on March 25<sup>th</sup> and Task Force Logistics continue to build operational capacity. AZNG personnel will not conduct missions on tribal lands; however, the supply chain stores have agreed that as AZNG back-fill their gaps in personnel they will reassign their workforce to delivery to their chains on tribal lands.
- Governor Ducey met with Utility Representatives and developed an agreement. Under the agreement, Arizona Public Service (APS), Salt River Project (SRP), Tucson Electric Power (TEP) and six electric cooperatives have all agreed to the following:

- No customer will have power to their home shut off during the remainder of the crisis for inability to pay;

- No penalties, late fees or interest will be assessed during this time.

- The utility companies will work with their customers to provide flexible options for payment, as well as guidance and choice of rate and payment plans. In addition, the utilities all agreed to the following innovative solutions:



- Customer service representatives will work with customers desiring to switch plans during this time if they no longer feel that their current plan is the best option for them.

- No customer will be required to stay in a plan that they chose under different circumstances if another one would be better for them and is approved under current regulatory rate structures. This will ensure that people have the flexibility to make the best decision for them, their family or their business.

- Customer service representatives are available for individualized service to the hospitals and health care providers during this time. The Healthcare system is being tested during this crisis; utilities committed to ensuring that their energy needs will be met.

- The utilities have agreed to work with one another across the state during this emergency to provide resources and coverage for one another to ensure continued reliable service. Electric utility crews will work cooperatively to maintain power reliability. Resources will be available for rural cooperatives should their crews need supplementing.

- As of Friday, March 20, all restaurants in Arizona counties with confirmed COVID-19 cases are required to provide dine-out options only.
- As of Friday, March 20, all bars, movie theaters, and gyms in counties with confirmed COVID-19 cases are required to close. Halt all elective surgeries in the state of Arizona.
- ADHS recommends that if someone in your family has tested positive for COVID-19, keep the entire household at home and contact your medical provider.
- Expiration dates on Arizona driver licenses are delayed.
- State-wide closures of Arizona schools through Friday, April 10, 2020.
- ADHS recommends to cancel or postpone mass gatherings of 10 or more people.
- ADHS recommends telework and other alternatives when available.
- DEMA is in the process of drafting a Major Disaster Declaration Request for COVID-19
