TONHC follows Arizona and CDC Phased Approach for COVID-19 Vaccination:

Recommendations are made with the following goals in mind:

- Decrease death and serious disease as much as possible.
- Preserve functioning of society.
- Reduce the extra burden COVID-19 has on people already facing disparities.

Phases to roll out COVID-19 vaccine:

Phase 1: Initial phase while vaccine supply is limited. 3 distinct groups: 1a, 1b and 1c. Expected Timeframe: December 2020 into Spring 2021

Currently ONLY Phases 1a & 1b are eligible to be vaccinated on the Nation.

Phase 1a:

Healthcare personnel and long-term care facility staff and residents

Examples:

- TONHC hospital and clinic staff
- Medicine men and women
- Home health workers
- AHSSNF
- Ambulance services
- Dialysis workers
- Police
- Fire
- Other First Responders



Phase 1b:

Frontlilne essential workers and people age 55 years and older

Examples:

- Elders age 55 years and up
- Health Transportation
- Government workers: District Leaders, Legislative Executive, and Judicial Branches
- Information Technology/Cyber Security
- Emergency Management, public safety staff
- Utility workers: ex: TOUA, Water/wastewater, Waste removal services
- · Educators, school workers, support staff, and child care workers
- Food producers, Grocers, and fuel (such as Bashas', Shell, gas stations)
- Health and Human Services (Child Welfare, Adult Protective Services, Behavioral Services, Family Assistance, Community Health, HOPP, Senior Services)
- Congregate living settings: Detention, group homes
- Tucson Indian Center
- IHS Area Office
- TO Nation Gaming Office



Phase 1c, Phase 2, and Phase 3 are NOT YET ELIGIBLE to receive vaccine. Phase 1c will be the next phase to open. TONHC will send out a PSA to announce when Phase 1c will open.

Phase 1c:

Adults with underlying medical conditions, and other essential workers.

Examples:

- Adults age 18 and up with Diabetes, obesity, chemotherapy/cancer treatment, immunocompromised, prolonged steroid use, pregnancy, organ transplant, chronic lung disease, moderate or severe asthma, serious heart problems, etc.
- Other essential workers such as non-medical transportation and logistics, food service/restaurants, housing, construction and finance, communications, law, media, commercial enterprises.

Phase 2: Increased availability of vaccine supply: expected Spring-Summer 2021

- Any persons remaining from Phase 1 populations
- Additional high-risk medical/critical populations
- General population

Phase 3: Vaccine is widely available: expected Summer 2021

- Any persons remaining from Phase 1 and Phase 2
 populations
- General Population

TONHC receives COVID-19 vaccines through the Arizona Department of Health Services. TONHC will send public announcements about when and where vaccination clinics will occur. As vaccine supply increases, vaccination clinics will expand to different Phase groups
