COVID-19 Testing

- Get tested with or without symptoms of COVID-19 or if you've had an exposure.
- Call your clinic when you are concerned and to ask when is the best time to get tested.

- Sells Hospital: Mornings Monday, Tuesday, Thursday and Friday 8:00 am 10:00 am by appointment only.
- San Xavier Health Center: Monday, Tuesday, Thursday and Friday 8:00 am 4:00 pm, Wednesday 1:00 pm to 4:00 pm
- San Simon Health Center: Monday, Tuesday and Thursday 8:30 am 10:00 am by appointment only.
- Pima County free testing centers: <u>Pima County COVID-19 Testing Centers Pima County</u>
 Testing is not intended for:
 - Occupational or return to work reasons.
 - Exposure testing if you have had a positive COVID-19 test in the last 3 months.

COVID-19 Vaccines will continue to be offered Monday-Friday at all clinic sites.

- San Simon Health Center: No vaccines on Wednesday.
- Due to lower demand, we will stop holding the larger vaccination events. Vaccinations will be offered through clinic appointments at all TONHC health care sites.

Inpatient (Hospital) Ward

- TONHC Sells Hospital Inpatient is currently open and has resumed admissions for inpatient services 24/7.
- Patient needing in-hospital care can be admitted to Sells Hospital or admitted to a regional hospital dependent on the patients medical resource needs.
- Due to COVID-19 inpatient continues to implement a visitor restriction policy.

Patients and Visitors when visiting TONHC please comply with the following:

- Must wear Surgical Mask: All patients, visitors and staff are required to wear surgical masks when on TONHC property. TONHC will provide a mask to all patients and visitors.
